

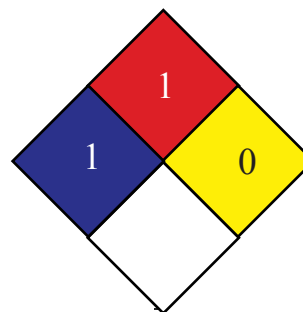

## 2. Hazards Identification

**Emergency overview** WARNING  
EYE IRRITANT. Skin irritation possible with prolonged exposure.
